



Ancaster Skating Club (ASC) TERMS OF AGREEMENT

Pre/CANSkate, AdvancedCANSkate & CanPOWERskate Programs

FALL/WINTER 2017-2018 (updated Aug 20, 2017)

1. All programs are Skate Canada approved.
2. All skaters are required to pay a **\$32.65 annual Skate Canada membership + \$3 Safe Sport fee and \$20 ASC admin fee**. These are not refundable/cannot be pro-rated.
3. Registration is completed online, by credit card payment only.
4. Any payments made by cheque, are payable to "Ancaster Skating Club". NSF payments are subject to a \$30.00 service charge. Skater will not be allowed to participate prior to NSF amount and service charge fully paid by cash.
5. Refund requests for all programs will only be considered within **3 sessions of your skater's start date** and must be submitted in writing on the ASC "Board Review" form which is available on the club website (see "Contact Us" page) and at the CanSkate desk in the lobby.
6. All refunds are subject to a \$40 administration fee.
7. By providing your email address you consent to receive ASC emails that will contain important updates about your program.
8. Skater **photographs** may be used for promotional purposes (e.g., club website, club FaceBook) **unless otherwise directed by the skater/parent**. It is up to the skater/parent to contact the club if you prefer not to have photos used for this purpose.
9. Ice time lost due to missed lessons **will not be refunded or rescheduled**. Cancellations due to inclement weather or other arena closures will not be refunded or rescheduled.
10. Skater may only participate on the day(s) he/she is registered for, not attend sessions offered on alternate dates.
11. All programs are subject to change. ASC reserves the right to cancel Programs due to insufficient registration.
12. The ASC Board of Directors reserves the right to suspend or terminate a skater's privileges after notification of improper behaviour of the skater and/or parent.
13. ASC reserves the right to use photographs of skaters (no names used) taken during regular program sessions and special events for promotional materials such as brochures, advertisements, website, unless notified otherwise in writing by parents or guardians or indicated in online registration.
14. C.S.A. approved hockey helmets are **mandatory** for skaters in Pre-CanSkate, CanSkate Stages 1–5, Advanced CanSkate, PrePower and CanPowerSkate. Full face protection is MANDATORY for skaters in PreCanSkate, PrePower & CanPowerSkate, and strongly recommended for skaters in CanSkate Stages 1-3. Skate guards are also required to ensure safe evacuation of the arena, if required.
15. Parents/Guardians are responsible for providing appropriate/properly maintained equipment.
16. Parents are ultimately responsible for the behaviour of their children. A parent or guardian **must be present** in the arena or lobby at all times while their child is on the ice.
17. Parents are prohibited from entering the ice surface. Parents are not to interrupt the Professional Coaches or Program Assistants during the sessions.
18. The Ancaster Skating Club, Professional Coaches, volunteers and Board of Directors will not be held responsible for any injury or loss of property, however caused, while participating in Club programs.
